The purpose of personal data processing is determined by your child's membership in the Association. The legal title for the processing of personal data is the fulfillment of contractual obligations based on this application and the Association's statutes, as well as the fulfillment of the Association's legal obligations and legitimate interests of the Association. The association processes personal data manually in paper form, as well as by automated means in electronic form. Recipients of personal data are mainly members of the association's body and coaches. Personal data are not transferred to third countries. The association undertakes that in case of processing or transfer of personal data, adequate steps will be taken to ensure data protection, so that your personal data is processed in

accordance with applicable legislation. We process your personal data for the time that is absolutely necessary to achieve the purpose of the processing. In connection with the processing of your personal data, you have the following rights, namely: (i) the right to access your personal data, in particular the right to inspect the association's record of your personal data; (ii) the right to information about the processing of your personal data; (iii) the right to correct and supplement your personal data; (iv) the right to erasure of your personal data; (v) the right to limited processing of your personal data; (vi) the right to object to the processing of your personal data; (vii) the right to transfer your personal data to another administrator; (viii) the right to information about the measures taken; (ix) the right to file a complaint against the processing of your personal data or the processing of your request to the Office for the Protection of Personal Data; (x) the right to withdraw consent to the processing of personal data; and (xi) the right to enforce your rights in court.
